- 2. The City Council shall consider, discuss and or take actions to appoint one new Board Member to fill the unexpired term of the former President of the 4-A CEDC Corporation, Drew Hubbard for 11-16-2015 to 12-31-2016 Mayor Nick Poldrack and City Manager Paul Catoe. Mayor Poldrack recommended Jack Birdwell to fill the unexpired term of former President Drew Hubbard. A motion was made by Councilwoman Merriman to appoint Larry Robinson to fill the unexpired term of the former President of the 4-A CEDC. Councilman Jeter seconded the motion. The motion carried 3-0.
- 3. The City Council shall consider, discuss, and or take actions to appoint two Board Members to the 4-A CEDC Board for three year terms beginning on January 1, 2016 and ending on December 31, 2018 Mayor Nick Poldrack. Mayor Poldrack recommended Jack Birdwell and Herman Law to the 4-A CEDC Board for three year terms. A motion was made by Councilwoman Merriman to appoint Jack Birdwell and Herman Law to the 4-A CEDC Board for three year terms beginning January 1, 2016 and ending on December 31, 2018. Mayor Pro Tem Payne seconded the motion. The motion carried 3-0.
- 4. The City Council shall consider, discuss and or take actions to appoint one Board Member to the 4-A CEDC to a one year term representing the Coleman Development Council Mayor Nick Poldrack (January 1, 2016 to December 31, 2016). Mayor Poldrack recommended Dr. Mike Edington to serve one year term representing the Coleman Development Council. Mayor Poldrack recommended reappointing Nelda Copley, Sandra Rose, Jessica Phillips, and Jimmy Watson. A motion was made by Councilman Jeter to re-appoint Nelda Copley, Sandra Rose, Jessica Phillips, and Jimmy Watson to the Coleman Public Library Board of Directors effective January 1, 2016 to December 31, 2018. Councilman Jeter seconded the motion. The motion carried 3-0.
