- 1. The City Council shall consider, discuss and or take actions regarding the recommendation of the City Manager and Mayor regarding the appointment of an engineering firm for the Downtown Revitalization Program (DRP) Grant for funding in the amount of \$250,000.00 from the Texas Department of Agriculture (TDA) with a minimum of a \$25,000.00 cash match in funds or a combination of cash and in-kind in the amount of \$75,000.00 for replacement of sidewalks within the 200 block of the downtown area of Commercial Street Mayor Nick Poldrack and City Manager Paul Catoe. The motion carried 3-0.
